NMDP Standards Cross Reference Tool

Purpose: This document serves as a resource for documents and materials which were included in both the 24th edition NMDP Standards and our policies and procedures. Users may find this listing a helpful reference as a companion to the 25th ed. NMDP Standards.

Background: Continued participation as an NMDP network partner requires adherence to NMDP membership requirements, federal or state laws and regulations (or non- U.S equivalent) or the standard of care prevailing in the relevant community. Each facility and individual must determine and follow additional laws, regulations, practices and procedures that apply in their community.

The NMDP Standards document sets forth the minimal requirements for programs working through the NMDP to facilitate hematopoietic stem cell transplants. Many of the requirements in previous editions of Standards were also contained in other documents and policies. Operational processes have become standardized within the cellular therapy industry and no longer require specific requirements in the NMDP Standards. In a continued effort to streamline and avoid duplication of the compliance requirements in multiple documents, the 25th Edition of the Standards has been simplified.
